Methods for an evidence-based agricultural policy Experiences, demand and new developments

The Common Agricultural Policy (CAP) is evolving to meet societal expectations, adapt to changing agricultural systems and respect budgetary constraints. Social scientists and economists are expected to contribute to the design of the CAP by providing scientific evidence on the effects and outcome of current and future policies. The periodical ex-ante, mid-term and ex-post evaluation studies create, at least in theory, opportunities for a dialogue between economics, social sciences and policy. Evaluation studies draw on qualitative and quantitative analyses that make use of a wide range of methodological approaches (e.g. simulation models, econometric analyses, descriptive case studies). However, questions emerge from the current evaluation practice: Do scientific evaluations cover all socially relevant issues of the CAP? Have these methods been helpful for evidence-based decision support? Which new methodological advances may help to find answers to important questions? Which additional insights could be gained from using economic experiments?

In the plenary session, the keynote speakers will elaborate on these questions and offer different perspectives on the role of scientific advice in agricultural policy-making. The contributed paper sessions, poster sessions and workshops, however, are also open to other topics. Therefore, this call addresses persons in the fields of agricultural economics, geography, history and law as well as rural sociology and development to present their recent work to an international audience of scientists and practitioners. We explicitly welcome early-career researchers to present their current work. Representatives of e.g. public administration, policy, education, agricultural extension services and research are encouraged to organise workshops in order to extensively discuss questions of practical or scientific relevance with experts and stakeholders. Submissions of short papers (2 pages) or workshop outlines (1 page) for the ÖGA conference are welcome by 6th May 2018 in German or English.

In 2018, the ÖGA also hosts two more events: the workshop of the REECAP (Research network on Economic Experiments for the CAP) and the preconference 'Evaluation of Gender Equality in Rural Development Programmes' the day before the ÖGA conference (for details see www.reecap.org and https://www.neecap.org an

Contributions for the REECAP workshop and to the preconference 'Evaluation of Gender Equality in Rural Development Programmes' should be prepared and submitted according to the respective calls (see http://oega.boku.ac.at for links to the calls).

3. Review process and publication of contributions

The programme committee will review the short papers and workshop outlines submitted for the ÖGA conference. The authors of the accepted submissions will be invited to give a paper presentation, a poster presentation or to organise a workshop at the conference. Accepted short papers and workshop outlines will be published in the conference proceedings. In addition, full manuscripts (max. 4,000 words) can be submitted to the peer-reviewed and SCOPUS-listed Austrian Journal of Agricultural Economics and Rural Studies by 7th October 2018 (see http://oega.boku.ac.at for the template).

4. Conference languages and Best Presentation Awards

Presentations of the plenary sessions are given in English. Short papers and workshop outlines are welcome in English or German. Depending on the number of submitted papers, at least one of the contributed paper sessions throughout the conference will be held in English. Speakers are requested to use the same language as in the short paper or workshop outline. The audience will vote on the best presentations, which will be awarded the *Best Presentation Award*.

5. Conference fee and registration

Conference participants are asked to register by 15th August 2018 (see http://oega.boku.ac.at for registration form). Likewise, the conference fee of €90 should be transferred to the ÖGA's bank account (IBAN: AT81 1200 0251 1113 6100; BIC: BKAUATWW) by 15th August 2018.
