

Notes for authors

Austrian Journal of Agricultural Economics and Rural Studies

Manuscripts submitted to the *Austrian Journal of Agricultural Economics and Rural Studies* are limited to a maximum of 4,000 words (including graphics, tables and references). The manuscript should use Times New Roman font with font size 11 and 1½-fold line spacing as well as continuous line numbering. All submissions are subject to a double-blind peer-review process with at least two reviewers. Accepted contributions will be made available free of charge on the ÖGA website (open access).

On the front page of the article:

Title in English / German

First and last name of all authors

Affiliation of authors: Name, Institution, email, as well as corresponding author

Acknowledgments

Abstract English/ German + keywords

The abstract should not exceed 120 words and should contain a maximum of 5 keywords. Tables should be created in MS Excel or MS Word. A placeholder can be used for tables in the text. The tables and graphics must be sent in separate files (incl. sources).

It is possible to apply two numbered heading levels:

- 1 Chapter title
- 1.1 Sub-chapter title

The citation in the text is as follows:

- In the text: surname author, publication year;
Pages are optional: surname author, publication year, page (s);
- Two authors: surname author and surname author, publication year;
- Three or more authors: surname author et al., publication year;
- A semicolon is placed between multiple references.

A full list of references must be included. It should be structured as follows:
